- (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.
- (d) To establish, manage, develop, maintain and grant aid in cash or in kind to hospitals, Schools, medical colleges, nursing institutions, dispensaries, maternity homes, child welfare centers and/or such other similar charitable institutions in India for the benefit and use of the general public.
- (e) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- (f) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, dharamshalas and rest houses, for use by public in general.
- (g) To encourage scholars, take expert advice and to impart knowledge to children.
- (h) To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- (i) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- (j) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.

(k) To grant aid or render assistance to other public charitable trusts or institutions.

5. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.

6. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 hereinabove.

7. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.

8. That for the furtherance of the objects of the trust, the trustees shall have the following powers:

(a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions.

(b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.

(c) To convert and deal with the trust property and/or any investments for the time being.

(d) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stocks or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.

- (k) To engage in any other lawful activity, this may be conducive to the promotion of any or all the objects of the Trust, mentioned above on no profit basis.
- (l) To co-operate with other institutions and associations having similar aims and objects.
- (m) To construct an Auditorium/Pravachana Mandiram and maintain it for the purpose of using the same for the community at large.

(o) To promote, organize, administer, establish, support, maintain, and/or grant aid to any person, institution or society or organization whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.

(p) To promote, assist and/or maintain all activities by whosever carried on or wherever carried on India in conformity with the objects of the Trust and as are conducive to the well being and general welfare of the nation or are conducive for advancement of any object or objects of general public utility not involving/ carrying on any activity for profit.

All the activities of the society, which are in the nature of objects of general public utility, shall be carried on without involving the carrying on of the activity for profit as contemplated in Sec.2(15) of the income Tax Act.1961, provided, that the application of the society funds and assets shall be done without any distinction of nationality, religion, caste, class, creed or sex.

3. All the activities of the Trust, which are in the nature of objects of general public utility, shall be carried on without involving the carrying on of the activity for profit as contemplated in Sec. 2(15) of the income Tax Act, 1961 provided, that the application of the Trust funds and assets shall be done without any distinction of nationality, religion, caste, class, creed or sex.

**E. MEMBERSHIP:**

1. The Membership of the Institution will be open to any person who has completed 18 years of age and who is not of unsound mind, irrespective of caste, religion or creed, race or class, but subject to what is in these rules provided.
2. A person, male or female, desirous of becoming a Member of the Trust shall apply to the Hon. Secretary in the form of application prescribed by the Managing Committee. The applicant will sign the application and his signature will be attested by atleast Two members of the Trust whose names are standing on the roll of members and who are a members atleast for a year on the date of such application.
3. Every member who is eligible and desires to enroll as a member to the Trust shall pay an admission fee for the following :
  - (1) In the case of Ordinary Member : Rs.1,000/-
  - (2) Life Member - Rs. 5,000/-
  - (3) Patron - Rs.25,000/-
  - (4) Honorary - NIL

The subscription payable by each class will be such as will be prescribed by the Managing Committee from time to time. The Managing Committee will also fix the entrance fee for ordinary membership which can be paid in one lump in advance for the year or by installments. The subscription for life members and patrons will be payable in advance along with the application for membership. The above said fee is not refundable

- To sell or give on lease any immovable or movable property of the Trust at such consideration and on such conditions as the Managing Committee may think fit provided that, no immovable property will be sold or given on lease without the prior approval of the General Body.
- To appoint necessary staff and workers for carrying on the work of the Trust under it.
- To open account or accounts with any scheduled banks/Private Banks/Co-operative banks in the name of the Trust as may be provided from time to time by the managing committee and to authorize operations thereon.

The affairs of the Trust shall be vested in a committee of management consisting of 7 members and shall continue in office for a period of 3 years and after the expiry of the said period the members of the committee shall be elected in the Annual General Meeting.

#### H. ALTERATION OF MEMORANDUM OF TRUST;

1. Any change or alteration of the memorandum of the Trust shall be done by resolution of the General Body meetings convened by the managing committee following the procedure and other formalities laid down under Trust Act.
2. The Managing Committee shall have power, from time to time, to make and alter bye-laws not inconsistent with these Rules. Any change must be immediately entered into the official copy of the Rules of the Institution, after approval by the Authority which should be open for inspection on request.
3. No amendments to the Memorandum of Association/Bye-laws/Rules and Regulation of the society shall be made which may prove to be repugnant to the provisions of Sec.2 (15), 11, 12, 13 and 80G of the Income Tax Act, 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.
4. In the event of dissolution or winding-up of the Trust, assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trust members of the Managing committee/Governing body but the same shall be transferred to another charitable Trust, whose objects are similar to those of this Trust as amended from time to time.
